Applicant hereby agrees that if applicant of any of their employees shall violate any provisions of the Act of the General Assembly of Missouri under which this application is made, or any other law of the State of Missouri, or any rule or regulation of the Supervisor of Liquor Control relating to the regulation, control, manufacture, brewing, sale, possession, transportation and distribution of intoxicating liquor, the Supervisor in his discretion, may suspend the operation of any permit granted hereunder by him, and during the time of such suspension, applicant hereby agrees to suspend operation of the business authorized by the application pending the investigation by the Supervisor of the violation by applicant of any law of Missouri or any of said rules and regulation above mentioned of the supervisor.
