<u>Wednesday April 18, 2017</u>: After opening nine (9) responses received for the above listed RFB, in the Commission Conference Room – in public, a decision was made to allow a time for a thorough review of said information by Road & Bridge Administrator Randy Haes. Thereafter an agenda request was made, and approved, to deliver a recommendation for award on Monday April 24, 2017.

<u>Monday April 24, 2017</u>: Subsequent to a thorough review of the detailed pricing offered, within each Bid Package Response received, Mr. Haes recommended a multiple award process as detailed on the attachments to the Taney County Commission. A motion to award as such was made and it passed unanimously.

Given the complex nature of this RFB, and the extensive details within each response, as we asked for, the Road & Bridge Office Manager – Kathy Roberts has prepared a complete Bid Tabulation Spreadsheet which clearly reflects all of the required information. This was a lot of work expertly prepared by her. Please see it as attached here. Dear Commissioners,

I have reviewed the bids received from nine vendors for various products within bid 373. This bid was for road oils, asphalt products and concrete. All of the vendors bid on one or two of the products and none bid on all three. I will recommend on group 6.1 for MC-road oils Apac Central as primary, Asphalt & Fuel Supply as secondary, and Coastal Energy as tertiary. On group 6.2 Emulsified road oils I will recommend Coastal Energy as primary, and Vance Brothers as secondary.

On group 6.3,6.4, and 6.5 for bituminous mixes laid in place, pickup at quarry, and cold mix I will recommend Tablerock Asphalt Construction as primary.

Secondary for group 6.3 only I will recommend Apac-Central, and tertiary for group 6.3 Young/ Kerans Construction.

Secondary for group 6.4 pickup at plant will be Leo Journagan Construction Co. no tertiary for this group.

Group 6.5 for secondary I will recommend Young/ Kerans Construction.

On group 6.6 for concrete delivered to various locations in the county I will recommend Concrete Company of the Ozarks (Conco) as primary and Tablerock Asphalt and Construction as secondary. Tertiary I will recommend American R&C LLC/ DBA Tri-Lakes Redi Mix.
