At present time the current contract has expired with an extension granted while we explore options. No other options have been discovered.

- 4. What research has been done to verify this vendor as the only known source? It is common knowledge that there are no other software solutions as those offered by Cartegraph, available especially no other Vendor who can deliver Standard HTML5, CSS3, and Java Script. Two meetings were held with this Vendor, one in person, and one conference call taking up several hours to discuss / determine continuing / adding exact solutions for our exact needs. Calls were made to other counties including Greene County where a software system from another company is in place there. Said system is not offering the same required services we need for them, Greene County. Boone County in Missouri as well as Clay County and Saline County have confirmed the fact that they are using Cartegraph and have for several years due to not being able to find any other company who can offer the same software solutions.

Also being provided are required subscriptions, licenses, and training.
- 7. Once this purchase is approved and processed, what additional upgrades/additions/supplies/etc. is anticipated / projected over the useful life of this product? *This is expected to be a 3 year term arrangement with eventual upgrades, additional tasks, and modifications to required processes.*
