ROAD MATERIALS

Preparation of Bids:

- 1. All prices and notations must be in ink or typewritten. No erasure permitted. Mistakes may be crossed out and corrections typed adjacent and must be initialed and dated in ink by person signing bid. All bids must be signed with the firm name and by a responsible officer or employee. Obligations assumed by such signature must be fulfilled.
- 2. Bidders are expected to examine this form, attached drawings, specifications, if any, and all instructions. Failure to do so will be at the Bidder's risk.
- 3. It will be the duty of each officer to see that his/her proposal is <u>delivered by</u> the time designated in this invitation.
- 4. Proposals may be withdrawn on written requests received from the bidder prior to the time fixed for opening. Requests may be submitted by telefax, email or telegram. Negligence on the part of the bidder in preparing his/her proposal confers no right to withdraw his/her proposal after it has been opened.
- 5. At the time fixed for opening of proposals, the content will be made public for the information of the bidder and others interested.

Such submissions will be rejected and deleted without notification to the sending party.

Response Clarification:

We reserve the right to request additional written or oral information from bidders in order to obtain clarification of their responses.

Length of Bid:

Bid shall remain in force for a minimum of twelve months from the date of award.

Billing and Payments:

Invoices will be submitted to each county office. Payment will be made within 30 days from receipt of accurate invoice.

Insurance Requirements:

The Contractor shall not commence work under this contract until they have obtained all insurance required under this paragraph and such insurance has been approved by the County. Insurance limits indicated below may be lowered at the discretion of the County.

- Compensation Insurance The Contractor shall take out and maintain during the life of this contract, Employee's Liability and Worker's Compensation Insurance for all of their employees employed at the site of work. Worker's Compensation coverage shall meet Missouri statutory limits. Employee's Liability limits shall be \$1,000,000.00 each employee, \$1,000,000.00 each accident, \$1,000,000.00 policy limit.
- Comprehensive General Liability Insurance The Contractor shall take out and maintain during the life of this contract. The amounts of insurance

- shall not be less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death.
- Commercial Automobile Liability The Contractor shall take out and maintain during the life of this contract, automobile liability insurance in the amount of not less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death, to protect themselves from any and all claims arising from the use of the Contractor's own automobiles, teams and trucks, both on and off the site of work.
- **Proof of Carriage of Insurance** The Contractor shall furnish the County with Certificate of Insurance which names the County as additional insured.

All materials shall be in accordance with the requirements of the 1999 Missouri Standard Specifications for Highway Construction and/or following specifications.

Material quantities shown on the material proposal represent an estimate and should not be taken as commitment by the county as to the quantity of material that will be used during the 2010 maintenance year. These bids shall remain in force for a minimum of twelve months from the date of award.

Taney County reserves the right to have the material tested for quality at their expense and to take whatever remedial action that may be required. Tests would be run to verify compliance with the applicable specifications.

All material is to be furnished to the County in accordance with directions given on the material proposal. Bids will be awarded for each group listed, aggregates may be awarded to more than one supplier based upon the lowest on the road cost. Taney County reserves the right to reject any and or all bids and to waive any and or all technicalities.

MC-800/MC-3000 Pugmill Asphalt Mixture

All materials shall conform to Missouri Standard Specification for Highway Construction, 2004 Edition.

The aggregate shall be manufactured crushed limestone. To assure the material is totally crushed, 100% of the parent aggregate shall be larger than the largest stone in the gradation to be used. The aggregate shall have a maximum absorption limit of 1.0% by weight. The aggregate shall have a maximum chert content of 10.0% by weight.

The crushed aggregate shall comply with the following graduation:

Bituminous material. MC800 and MC3000 oil shall comply with Section 1015 of the Missouri Standard Specifications. To optimize seasonal performance, the County reserves the right to request, solely at its discretion, either liquid asphalt be used in the mixture.

Mixing. Upon pugmill mixing, the aggregate shall contain not more than 1% moisture (surface dry), shall not be heated or dried to reduce moisture level, and shall be introduced at ambient temperature. The temperature of the liquid asphalt shall not be less than 220 degrees F and not more than 270 degrees F. MC800 or MC3000 liquid asphalt or combination thereof shall constitute no less than 4.25% and no more than 5.5% by weight of the total mixture.
