Mr. Paulson also explained that by Opting in on Springfield Foreign Trade Zone there would be no cost to Taney County, but would provide an advantage to manufacturers who might want to use this process.

Bob Paulson explained that the zone will be all of Taney County. Any manufacturer can opt to belong to the foreign trade zone and then would be responsible for expenses. Ron Houseman called for the vote: Motion passed by vote: Houseman (yea), Strafuss (yea), and Strahan (yea).
