FILL DIRT AGREEMENT

COMES NOW the Taney County Commission on behalf of Taney County, Missouri, (hereinafter "Taney County") and enters into this agreement with Cross Bartlett (hereinafter Owner), regarding the dumping of dirt fill on Owner's property, and the particulars of the agreement are as follows:

WITNESSETH:

WHEREAS, Taney County, Missouri's Road and Bridge Department would benefit from a location near ongoing construction to dump excess and unneeded fill dirt; and,

WHEREAS, having said location would save Taney County's Road and Bridge Department a considerable amount in hauling costs; and

WHEREAS, Owner will benefit from having needed fill dirt dumped on Owner's property;

NOW THEREFORE IT IS AGREED AND COVENANTED BETWEEN THE PARTIES AS FOLLOWS:

General Provisions.

Taney County, as the need arises, is granted permission by Owner to dump fill dirt upon locations on Owner's property that Owner has previously designated to receive such material.

Term and Notice.

The term of this agreement shall commence upon the first date upon which all parties have signed this agreement and shall continue until terminated by one party or the other.

Hold Harmless

Owner agrees that it will hold Taney County, its employees, representatives, heirs and assigns harmless from any claims arising from or relating to this agreement except for any gross negligence.

EXHIBIT A

TANEY COUNTY REGIONAL SEWER DISTRICT 2019 ANNUAL NON-PROJECT SPECIFIC FUNDING AGREEMENT SUMMARY OF EXPENDITURES

The following summary of expenditures represents a reasonable expectation of what the Taney County Regional Sewer District anticipates during the 2019 calendar year for non-project specific items.

The list number of each item shown below corresponds to the number listed on the 2019 approved capital improvement budget.

No. 10 Existing System Studies

2019 Cost: \$5,000.00

Project Description: This line item may be necessary to study various sewer systems throughout the year that are not on the District's current list of projects.

No. 11 Grinder Pump Upgrades

2019 Cost: \$100,000.00

Project Description: This line item serves to upgrade the District's low-pressure sewer system. Budget dollars for 2019 will assist the District in purchasing the final pumps for the upgrade program and restarting its grinder pump rebuild program.

No. 12 Lift Station Upgrades

2019 Cost: \$150,000.00

Project Description: This line item will be used to make upgrades to various lift stations. Some of the upgrades to be made in 2019 will include upgrading lift stations with new or rebuilt pumps, valves, piping, and other miscellaneous improvements.

No. 13 Wireless Telemetry/SCADA

2019 Cost: \$25,000.00

Project Description: The District will use budget dollars in 2019 and beyond to fund the installation of SCADA on newly constructed lift stations and treatment facilities along with ongoing support and periodic upgrades to the existing SCADA system.

No. 14 Continuing I & I Issues

2019 Cost: \$50,000.00

Project Description: The District will use this line item to perform work and purchase equipment and services (such as flow meters and smoke testing machines) allowing for the identification of inflow and infiltration (I&I). Repair work to correct I&I issues may also be completed with this line item.

No. 15 Master Plan Update

2019 Cost: \$10,000.00

Project Description: The master plan has been finished and updated by District staff and the District is now working to adopt the plan and request Tier 2 Continuing Authority designation from the Missouri Clean Water Commission. The master plan update will serve as a guiding document to complete the needed capital improvement sewer projects in the county. The designation of the District as a Tier 2 Continuing Authority will serve to assist in the regionalization of private wastewater treatment facilities in the county. This line item allows the District to utilize outside consulting engineers to assist with and review the completed master plan, to peer review the finished document, as well as provide for any other necessary fees to obtain the Tier 2 designation, such as legal fees, etc.

AMENDMENT TO INTER- GOVERNMENTAL FUNDING AGREEMENTS: SANITARY SEWER REHABILITATION PROJECT (Phase 5) TIME EXTENSION

Commissioner Williams moved to approve the Amendment to the Inter-Governmental Funding Agreement by and between Taney County and the Taney County Regional Sewer District for Sanitary Sewer Rehabilitation Project Phase 5 with a time extension. WHEREAS, the parties desire to reduce this Amendment to writing.
