The additional services shall be in an amount not to exceed one thousand five hundred thirty dollars and nine cents (\$1,530.09) without further authorization. The total design services shall be in an amount not to exceed one hundred twenty eight thousand five hundred eighty seven dollars and fifty one cents (\$128,587.51).
