SPECIAL SCHOOL BOND ELECTION
PROPOSITION O**

Shall the Board of Education of the Spokane R-VII School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Six Million Dollars (\$6,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new field house to include a concession stand, press box, outdoor restrooms, and new sound system; to implement safety and security improvements, including secure entrances, high resolution cameras, and shatterproof film; to upgrade and expand locker rooms; to remodel the old Spokane Middle School for increased classroom space and relocation of central office; to repair and/or replace roofs at Spokane High School; to provide necessary upgrades to restrooms and replace flooring as necessary District-wide; to the extent funds are available, complete other repairs and improvements to the facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0. 7445 per one hundred dollars of assessed valuation of real and personal property.
