Preparation of Bids:

1. All prices and notations must be in ink or typewritten. No erasure permitted. Mistakes may be crossed out and corrections typed adjacent and must be initialed and dated in ink by person signing bid. The Taney County Purchasing Department will be accepting sealed bids on a hydraulic thumb to be installed on our Hitachi Zaxis 200LC-3 Hydraulic Excavator SN: FF01G6Q312246, please bid the following:

Provide all necessary labor and parts related to installation of a hydraulic thumb including but not limited to the following:

-Convert the machine's auxiliary hydraulics from one-way flow to one-way and two-way flow

-include a combination selector valve

-include a joystick controller

-include an auxiliary hydraulic circuit relief cartridge

-include a conversion kit for bi-directional hydraulic flow

- Provide and install a hydraulic thumb, 1,190# minimum weight, 28" minimum width and of the appropriate length to be compatible with the 42" bucket and coupler associated with this machine. Thumb shall feature a mechanical thumb lock (to eliminate drift) and cylinder rod protection.

Worker's Compensation coverage shall meet Missouri statutory limits. Employee's Liability limits shall be \$1,000,000.00 each employee, \$1,000,000.00 each accident, \$1,000,000.00 policy limit.

Comprehensive General Liability Insurance - The Contractor shall take out and maintain during the life of this contract. The amounts of insurance shall not be less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death.

Commercial Automobile Liability - The Contractor shall take out and maintain during the life of this contract, automobile liability insurance in the amount of not less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death, to protect themselves from any and all claims arising from the automobiles, teams and trucks, both on and off the site of work.

Proof of Carriage of Insurance – The Contractor shall furnish the County with Certificate of Insurance, which names the County as additional insured.
