- 2. Closing: Sealed Bids must be delivered before <u>2:00 P.M.</u> central time on <u>Wednesday May 1</u>, <u>2013</u> to the Taney County Purchasing Department as listed on page one. Bidders should take into account all possible risks of their Bid not arriving in time when electing to mail in Bids too close to the above closing date. Often the Post Office leaves a "pick up slip" in our PO Box which may / may not allow us time to retrieve said item. It is the Bidders responsibility, not the county, nor the Post Office to ensure their sealed Bids are <u>delivered</u> in time to the Purchasing Department. The amounts of insurance shall not be less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death.
- 3) Commercial Automobile Liability The Contractor shall take out and maintain during the life of this contract, automobile liability insurance in the amount of not less than \$2,000,000.00 combined single limit for any one occurrence covering both bodily injury and property damage, including accidental death, to protect themselves from any and all claims arising from the use of the Contractor's own automobiles, teams and trucks, both on and off the site of work.
- 4) **Proof of Carriage of Insurance** The Contractor shall furnish the County with Certificate of Insurance which names the County as additional insured.

The Taney County Commission has the right to accept or reject any part or parts of all bids, to waive technicalities, and to accept the offer the County Commission considers the most advantageous to the County. Taney County reserves the right to award this bid on an item-by-item basis, or an "all or none" basis, whichever is in the best interest of the County.
- 3. Bidders must use the bid forms provided for the purpose of submitting bids, must return the bid and bid sheets comprised in this bid, give the unit price, extended totals, and **sign the bid**.
- 4. When products or materials of any particular producer or manufacturer are mentioned in our specifications, such products or materials are intended to be descriptive of type or quality and not restricted to those mentioned.

5. Do not include Federal Excise Tax or Sales and Use Taxes in bid process, as law exempts the County from them.

- 6. The delivery date shall be stated in definite terms, as it will be taken into consideration in awarding the bid.

Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

This office has received the following questions as listed below. Keeping in full compliance with the instructions stated within this RFB we are submitting our best possible answers to the below questions - listed in red.

- 1. On page two of the bid form, item #9, please clarify what information you are referring to in regard to "prevailing wage considerations"? ANSWER: Vendor must comply with current state law governing prevailing wage which is standard when performing any "labor" on County owned property. In this case those Vendor Employees making deliveries which require "labor". Order #19 available on our website.
- 2. On page three, number 10, does the bid stay in effect for "ninety" or "(30)" days? ANSWER: That is a TYPO which in any case of such a typo the written word prevails over the numerical, thus NINETY DAYS.
- 3. Please refer to page 4, Background Information, item 1.) We would like to provide a delivered price from Hilda quarry to your Hilda Yard. We will not have personnel at Hilda quarry at all times available for aggregate to be picked-up. We would therefore write in the picked-up column "No Bid". Is this acceptable? ANSWER: In this case, as I have in the past, will have to answer with a basic response reminding all Vendors that the Bid process itself allows for various options including the invitation to be creative. This item includes the words <u>MUST</u> in the first part and <u>option</u> in the second part. As such I suggest Vendors respond accordingly with their best answer. Often there are areas within an RFB as complicated as this where a "NO BID" response is acceptable.
- 4. We will not be producing all material types requested at each quarry location from which we will bid. We would mark in the "delivered" or "Picked-Up" column "No Bid" for the specific material type we are not producing. Is this acceptable? ANSWER: Often there are areas within an RFB as complicated as this where a "NO BID" is acceptable.
- 5. In order to provide aggregate pricing from separate quarry locations, we are assuming that we should submit a separate Bid page for each location. How do you want each Bid page identified? ANSWER: Obviously the reviewer MUST know what they are looking at. Previous year Bidders have made separate copies for each location. Again the reviewer must be able to know which is what.
