ADMINISTRATIVE & DEPARTMENTAL FUNCTIONS

KANAKUK/WHITE FAMILY CEMETERY

Presiding Commissioner Houseman suggested that the County Commission add to their list of tasks to develop a consistent system that we utilize for vacations and a packet if need be that is distributed when vacations are asked for or considered and perhaps vacations should come from Road & Bridge or Planning and Zoning whichever department we determine to make the presentation and all of the work being done before it arrives before the Commission.

TANEY COUNTY SOIL & WATER REIMBURSEMENTS
