PROCLAMATION CELEBRATING 50 YEARS OF SERVICE OF THE TANEY COUNTY HEALTH DEPARTMENT

Commissioner Strafuss moved to approve the Proclamation recognizing 50 years of Service of the Taney County Health Department as follows:

PROCLAMATION

A PROCLAMATION by the Commissioners of Taney County, Missouri, recognizing the 30th Anniversary of the Taney County Health Department Friday, November 18, 2011.

WHEREAS, we hereby recognize and acknowledge 50 years of public health service to the residents of Taney County, and the immeasurable contribution of these services to the quality of life in our County; and

WHEREAS, the mission of the Taney County Health Department is to improve the health and environment of the community through leadership, education, and coordination of services with excellence, professionalism, and compassion.

WHEREAS, the vision of the Taney County Health Department is to ensure Taney County is a community of healthy people living in a safe environment.

WHEREAS, the public health measures to control and eliminate infectious diseases, improve environmental sanitation, and promote healthy lifestyle practices have been a great contributor to the improved health status and increased life expectancy for Missouri residents, such as Missourians now have an average life expectancy at birth of 76 years; and

WHEREAS, Taney County's public health system plays an essential role in controlling the spread of communicable diseases, including influenza and food borne illness; and

WHEREAS, public health plays a critical role in eliminating health inequities and preventing chronic diseases and injuries, resulting in improved productivity and decreased health care costs for all of Taney County; and

WHEREAS, the Taney County Health Department values constant improvement through teamwork, learning, and sharing of information, and strives to make a positive difference through education and communication; treating each other and those, they serve with respect.

WHEREAS, Taney County's public health system is a critical component of the County's emergency response capacity to natural and man-made disasters and widespread disease outbreaks in Taney County;
