This REVISED Bid Tabulation Form reflects a significant cost savings for Taney County by using WCA despite the distance factor. The critical area revised is specific to mileage costs after adjusting to use **ACTUAL USAGE** of fuel. The previous calculations used the same cost per gallon amount, \$3.02, but incorrectly multiplied that by total miles. These corrected figures – again using actual gallons of fuel used – indicate true savings at **all three volume levels** with WCA. (TOTAL COST PER TON.) That stated it is still desired that we include Allied as a destination when backed up given their proximity. Based on these calculations the Presiding Commissioner asked for the Taney County Commission to reconsider a previous motion. Commissioner Strafuss moved to reconsider the vote of August 20th, bid number 201207-191, a motion was made and it passed unanimously. Commissioner Strafuss moved to award bid number 201207-191 to WCA *and* Allied Waste, the awarding of services to be determined by the amount of savings per ton to the county. Said motion passed unanimously.
