#### SEWER DISTRICT AGREEMENTS

Eddie Coxie and John Soutee with the Taney County Regional Sewer District went before the Commission regarding a personal property Bill of Sale and a Deed Agreement.

Commissioner Strafuss moved to approve the personal property Bill of Sale between Taney County and Taney County Regional Sewer District. Commissioner Strahan seconded the motion. The motion passed by vote: Houseman (aye), Strahan (aye) and Strafuss (aye).

#### BILL OF SALE

This BILL OF SALE is made and entered into on this <u>27</u> day of August, 2012, by the County of Taney, Missouri (hereinafter "County") to the Taney County Regional Sewer District ("hereinafter "District"), each of them being a body politic and corporate.

#### RECITALS

WHEREAS, County and District entered into an Intergovernmental Agreement on December 29, 2011; and

WHEREAS, District possesses various itoms of personal property used in the operation of the District; and

WHEREAS, the Intergovernmental Agreement requires County to provide District, with a bill of sale for all personal property currently used by the District, with the exception of phone equipment and handsets; and

WHEREAS, County desires to transfer and assign all of its right, title and interest in and to the personal property currently used by the District, with the exception of phone equipment and handsets.

NOW, THEREFORE, for goal and valuable consideration, the receipt and sufficiency of which are acknowledged, County and District covenant and agree as follows:

1. County transfers, conveys and assigns to District, its successors and assigns, all of the right, title and interest of County in and to all personal property currently used by the District, with the exception of phone equipment and handsets. For purposes of this Bill of Sale, "personal property" shall include, but not be limited to, the following: computers, printors, fax machines, desks, chairs, tables, supplies, tools, equipment, inventory, accounts receivable, records, files, computer software and programs, machinery. District accepts the transfer and assignment of the right, title and interest of County in and to said personal property.

2. County represents and warrants that it has good and marketable title to the personal property, that the personal property is free and clear of all security interesta, liens, title retention agreements or other encombrances, and that it has full right, power and authority to transfer and assign the personal property to District.

3, . All personal property transferred herein is transferred in "as is" condition and where presently located,
