





BENEFITS OF BUSINESS INCUBATOR

Chrystal Irons, Jonas Arjes, and Cy Murray with the Branson Chamber of Commerce Incubator Committee came before the Commission to discuss the benefits of a Business Incubator. They stated that Taney County's Self-Employment Rate was 24.8% in 1990 but has steadily decreased to 11.4% in 2010 while the state and national rate has increased.

The Business Incubator is designed to accelerate the successful development of entrepreneurial companies through business resources and support. Types of Business Incubators include Manufacturing, service/specialty, technology, and a mixed use.

The committee is asking for consideration of a 2013 budget allowance for a feasibility study and NAIB Membership. Discussion ensued regarding the length and the process of the study. Discussion also ensued regarding which committee would formally request the monies from the County. The Commission decided that Jonas would gather the necessary information and present it to the Commission.

ON-SITE WASTEWATER VIOLATIONS

Bob Atchley, Scott Starrett, and Mike Cole with Planning and Zoning came before the Commission to discuss a contract between Taney County and the Missouri Department of Health and Senior Services that was entered into in September 2011. The question is the handling of violations. Currently Mr. Starrett and Mr. Cole would go on location, investigate the complaints and then, if any existed, the violations would be referred to the Taney County Health Department. The Taney County Health Department has expressed a concern about being the entity handling the violations. Mr. Starrett and Mr. Cole have investigated 10 – 12 complaints but have had only 1 violation in the year's time.

The contract under section 4.3 states the County is to provide a violation letter to any violators and then to refer that violation to the Prosecuting Attorney. RSMo 701.038 it refers to the Taney County Health Department and Senior Services or its agents. The County Health Department has indicated they no longer wish to handle these violations. This is an unusual situation due to the County having the contract with the State instead of the Health Department having the contract with the State.

The Commission directed this to be forwarded to legal counsel to review to see if the County is able to step into this roll.

LIBRARY AND 911 PROPOSED TAX ISSUE

Commissioner Houseman reminded the Commission the Library Board has formally presented a tax initiative of 20 cents for every \$100 dollars assessed valuation for the April 2013 Election. The 911 Board and 911 Stakeholders have also asked for alternative funding for 911, but didn't specify an exact election date but stated "the sooner the better".

Commissioner Strahan commented about the 911 tax issue and said he is ready to make a motion to approve a 3/16 with a sun-set provision to be re-voted in 10 years. Discussion ensued concerning the amount needed to properly fund this service and the centralization of a 911 facility.

Commissioner Strahan moved to place the 911 funding via a sales tax on the April 2013 Ballot. Commissioner Houseman seconded the motion. Commissioner Strafuss would have liked the

Commission to look at a possible realignment of the current Sewer Sales Tax. Clarification was made that if this tax passes then the Commission would go to the voters and see about the surcharge on landlines being done away with. The motion carries by vote: Houseman (aye), Strahan (aye), and Strafuss (nay).

Commissioner Houseman asked the 911 Board and Stakeholders to bring information on the amounts that would be needed to adequately fund a centralized 911. Dave Woolery with the 911 Board appreciates the Commission giving them the opportunity to go back and refigure the numbers needed for funding the centralized 911. Commissioner Houseman also thanked the 911 Board and the 911 Stakeholders of the cooperation they have shown working on this issue.

Commissioner Houseman introduced the tax issue presented by the Library Board.
