I have reviewed the qualifications from both engineering firms that submitted RFQ per request. I will rate both on criteria of:

Experience & Technical Competence	30 points
Capacity and Capability	30 points
Past Record of Performance	40 points

Both firms are experienced and capable of engineering this project for us; they both have the technical competence and capacity. I would give both 30 points for the first two categories.
