<u>Wednesday April 18, 2018:</u> After opening responses from the above listed companies, today, initial details were noted and documented by Road & Bridge Administrator Randy Haes and Assistant Administrator Devin Huff. Both packages will be thoroughly reviewed by Mr. Haes & Mr. Huff. An agenda request has been made, and approved, to deliver a formal recommendation for award to the Taney County Commission on Monday April 23, 2018.

Monday April 23, 2018: After a thorough review process by Mr. Haes and Mr. Huff a determination was made that both responses are fully qualified and compliant with all bid requirements and specifications as asked for. Taney County Assistant Road & Bridge Administrator, Devin Huff, formally recommended to the Taney County Commission;

- For Asphalt needs to be <u>laid in place</u> by Bidder (Item #'s 3.2.1 & 3.2.2 as priced above.) award to Leo Journagan Const., Inc. of Springfield, Mo. as Primary Supplier and Table Rock Asphalt Construction Company, Inc., of Branson, Mo. as Secondary Supplier.
- For Asphalt needs that can be <u>picked up at Bidders Plant</u> by County Employees (Item #'s 3.3.1, 3.3.2, 3.3.3 & 3.4.1 as priced above.) Mr. Huff's recommendation is reversed with Table Rock being Primary, Journagan Secondary.

Awarding, as recommended above, ensures a process resulting in significant cost savings for Taney County Missouri. Mr. Huff's signed recommendation letter is hereby included.

A motion was made to award as such and the Taney County Commission then voted unanimously to award accordingly as stipulated above. A subsequent Agreement, for both, will be for 12 months, with a 12 month renewal clause – per mutual agreement on pricing, etc, at that time. Thank you.
