#### INTERGOVERNMENTAL DISPATCH AGREEMENT

This Agreement, dated the <u>31<sup>st</sup></u> day of <u>July</u>, 2019, is entered into by the County Commission of Taney County Missouri, (hereinafter "County Commission"), the Taney County Sheriff (hereinafter "Sheriff"), and Western Taney County Fire District (hereinafter "Fire District") pursuant to Section 72.210 RSMo., and Section 72.220 RSMo., et seq.

WHEREAS, County Commission, Sheriff, and Fire District each recognize the need for centralized and efficient dispatching of emergency equipment and personnel, including those of the Fire District and that the dispatching facility located in the Sheriff's Office, in Forsyth, Missouri, is suited to provide such dispatching services for and on behalf of Fire District, and that it would be efficient and in the best interest of all concerned that a cooperative agreement with regard to the dispatching and dispatching facilities be reached between Sheriff, and Fire District, and approved by the County Commission.

NOW, THERFORE, the parties hereby agree as follows:

- Sheriff, through the dispatching facilities located in the Sheriff's Office, Forsyth, Missouri, shall provide all dispatching services for Fire District. Sheriff shall maintain contact assignment sheets and maps provided by Fire District for location, directions, and vehicles dispatched. Sheriff will also provide back-up dispatching services on Simplex facilities in the event of some failure of the Fire District repeater and other equipment, and Fire District agrees to pay all expense of the back-up dispatching services.
- 2. Fire District shall provide maps as it deems appropriate for use by the dispatcher.
- 3. Fire District may, at its option and discretion, up-grade the dispatching facilities by supplying Fire District owned and maintained equipment. Equipment supplied by Fire District pursuant to this paragraph will remain the property of the Fire District, subject to removal by Fire District at Fire District's option or upon termination of this agreement. Installation, improvement, and maintenance of equipment or facilities may only be done by personnel approved by Sheriff.
- 4. This Agreement, on and after its signing by all parties hereto, shall remain in effect through and including <u>31<sup>st</sup></u> day of <u>July</u>, 2021. However, this Agreement can be terminated without cause, by any party upon Sixty (60) days written notice. Additionally, the parties may, by agreement, terminate this Agreement upon execution of a substitute Agreement.
- Pursuant to Section 70.220 RSMo., County Commission approves this contract and cooperative action of Sheriff and Fire District. All parties agree that County Commission assumes no duties or liabilities under this Agreement.
