FILL DIRT AGREEMENT

WITNESSETH:

WHEREAS, Taney County, Missouri's Road and Bridge Department would benefit from a location near ongoing construction to dump excess and unneeded fill dirt; and,

WHEREAS, having said location would save Taney County's Road and Bridge Department a considerable amount in hauling costs; and

WHEREAS, Owner will benefit from having needed fill dirt dumped on Owner's property;

NOW THEREFORE IT IS AGREED AND COVENANTED BETWEEN THE PARTIES AS FOLLOWS:

General Provisions.

Taney County, as the need arises, is granted permission by Owner to dump fill dirt upon locations on Owner's property that Owner has previously designated to receive such material.

Term and Notice.

The term of this agreement shall commence upon the first date upon which all parties have signed this agreement and shall continue until terminated by one party or the other.

Hold Harmless

Owner agrees that it will hold Taney County, its employees, representatives, heirs and assigns harmless from any claims arising from or relating to this agreement except for any gross negligence.

ANIMAL CONTROL JURISDICTIONAL AGREEMENT WITH VILLAGE OF SADDLEBROOKE (#18-002AC)

Sherry Simpson, Animal Control Supervisor, was present. Presiding Commissioner Scofield referenced a letter from their attorney.

Commissioner Williams moved to approve the Agreement by and between Taney County and the Village of Saddlebrooke. Commissioner Wyatt seconded the motion. The motion passed by Scofield (aye), Williams (aye), and Wyatt (aye).

AGREEMENT (Animal Control)

THIS AGREEMENT, made and entered into on this 30 day of <u>lecember</u> ("Effective Date"), by and between Taney County, Missouri ("County"), a county of the first classification, and the Village of <u>and entropy of the County</u>, a village organized under Chapter 80 of the Revised Statutes of Missouri.

WITNESS:

WHEREAS, the County owns and operates an animal control facility ("Facility") for the purpose of providing care for lost, stray, vicious, sick and injured animals and ("Animals"); and

WHEREAS, the County and Village desire to enter into this Agreement to enable the Village to utilize the Facility and the resources of the County for the temporary shelter and care of Animals; and

WHEREAS, the County and Village desire to set forth the respective duties and responsibilities of the parties; and

WHEREAS, section 70.220, RSMo. permits political subdivisions to contract and cooperate with one another for the planning, development, construction, acquisition or operation of any public improvement or facility or common service; and

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the parties agree as follows:

1. <u>Term.</u> The term of this Agreement shall be from the Effective Date to December 31, 2020, and shall automatically renew for additional one (1) year terms unless terminated by either of the parties.

<u>Covered Services.</u>

a. <u>Care of Animals.</u> In consideration of the Intake Fee set forth in Schedule A, the County shall provide appropriate food, water, boarding, cleaning supplies and labor necessary in order to care for each Animal accepted by the Facility for the period of time set forth in Schedule A. The additional holding fee shall apply for any Animal housed longer than the holding period, as provided in Schedule A, at the option of the Village. In the event the owner of an Animal is not located and the Animal is not claimed and redeemed, the County agrees to attempt to place each Animal for adoption or to provide a humane euthanasia.

b. <u>Specified Vaccination of Animals.</u> Upon transportation and acceptance of an Animal by the Facility, the County shall vaccinate: (1) a canine Animal for parvo and upper respiratory/kennel cough; or (2) a feline Animal for leukemia and upper

ECONOMIC DEVELOPMENTAL PROJECT CONTRACT 2020 (#19-152CM)

ECONOMIC DEVELOPMENT PROJECT CONTRACT BETWEEN TANEY COUNTY, MISSOURI AND THE BRANSON/LAKES AREA CHAMBER OF COMMERCE

This Contract, made this 2 day of December, 2019, by and between Taney County, Missouri ("County") and the Branson/Lakes Area Chamber of Commerce ("Chamber").

WHEREAS, County and Chamber desire to enter into an agreement to promote the economic well-being of the public by obtaining the services an economic consultant in order to bring new jobs and increase business development in Taney County, Missouri.

NOW, THEREFORE, in consideration of the mutual promises contained in this Contract and other good and valuable consideration, the parties agree as follows:

1. <u>Term.</u> The term of this Contract shall be effective as of the date of execution by the parties and shall terminate on December 31, 2020, and shall not automatically renew, except upon the mutual agreement of the parties.

2. <u>Fee.</u> In consideration of the services to be provided by the Chamber pursuant to this Contract, the County shall pay to the Chamber the sum of fifty thousand dollars and no cents (\$50,000), within thirty (30) days of the date this Contract is fully executed.

3. <u>Services to be Provided</u>. During the term of this Contract, the Chamber shall operate an organization to be known as the Taney County Partnership (hereafter "Partnership") for the purpose of promoting economic development in Taney County, Missouri. For the term of this Contract, the Chamber will employ an Executive Director who shall be responsible for the day-to-day administration and operation of the Partnership. All salary and benefits of the Executive Director shall be the responsibility of the Chamber. The services to be provided shall include, but are not limited to:

- Serve as the point of contact for economic development in Taney County, Missouri;
- Development and performance of a comprehensive program to promote Taney County as a prime area to locate new businesses and expand existing businesses
- c. Evaluate and work to develop and maintain appropriate infrastructure necessary to foster economic development opportunities in Taney County, Missouri;
- Engage in business retention and expansion efforts by soliciting input from existing businesses to determine how best to serve existing business and evaluating the development of programs and efforts to leverage existing assets to promote business;
- e. Evaluate and conduct appropriate business recruitment activities designed to recruit prospective businesses to the community and provide new jobs;
- f. Assess issues of concern to local businesses and assist with promoting a healthy business climate within Taney County, Missouri;

INTERGOVERNMENTAL AGREEMENT BETWEEN TANEY COUNTY, MISSOURI AND CITY OF FORSYTH, MISSOURI

This Agreement made and entered into this <u>day of</u>, 2019 ("Effective Date"), by and between the County of Taney, Missouri ("County") and the City of Forsyth, Missouri ("City").

WHEREAS, section 70.220, RSMo. permits political subdivisions to contract and cooperate with one another for the planning, development, construction, acquisition or operation of any public improvement or facility or common service; and

WHEREAS, the County and the City are political subdivisions of the State of Missouri, and are authorized to enter into a joint agreement for common services of good to the public; and

WHEREAS, the County and the City agree to provide certain road maintenance services as a common service to the public of Taney County and the City of Forsyth.

WHEREAS, the County maintains a public road, located in Taney County, known as Casey Road, as a public service; and

WHEREAS, the City maintains certain public roads, located in the City of Forsyth, known as Blackhawk Road and Nicholas Drive, as a public service; and

WHEREAS, City of Forsyth must travel on Casey Road in order to maintain Blackhawk Road;

NOW THEREFORE, in consideration of the mutual promises and covenants set forth herein, the parties agree as follows:

1. <u>Incorporation</u>. The whereas clauses set forth above are incorporated as findings of the County and City as through fully set forth herein by reference.

2. <u>Term; Termination</u>. The initial term of this Agreement shall be for a period of one (1) year, commencing on the Effective Date of this Agreement. This Agreement shall automatically renew upon expiration of the initial term for additional one (1) year periods thereafter. This Agreement may be terminated at any time, without cause, by either party, by providing thirty (30) days' written notice to the other party.

3. <u>Snow Removal by the City.</u> City agrees to perform snow removal on Casey Road from the junction of US Highway 160 and Casey Road to the junction of Casey Road and Blackhawk Road, as needed and using the same standard as other city streets.

4. <u>Tree Maintenance by the County.</u> County agrees to perform tree trimming maintenance to over hanging trees on Nicholas Drive from the junction of Y Highway and Nicholas Drive to the junction of Y Highway and Old Forsyth Road, as needed and using the same standard as other county streets.
