HOWE PARK ROAD EASEMENT #19-159RB

ORDER OF THE TANEY COUNTY, MISSOURI COMMISSION ACCEPTING, ESTABLISHING AND DEDICATING HOWE PARK ROAD

WHEREAS, a Replat of Mincy Valley Homestead Acres, dated August 5, 2005, was recorded in the office of the Taney County Recorder of Deeds, on August 18, 2005, in Plat Book/Slide H, Page 456-458; and

WHEREAS, a General Warranty Deed, dated August 17, 2005, was executed by Mary Bell Howe in favor of Taney County, Missouri, and recorded in the office of the Taney County Recorder of Deeds, on August 23, 2005, in Book 471, Page 6402-6403, conveying the Arena Parcel of the Replat of Mincy Valley Homestead Acres subdivision to Taney County, Missouri; and

WHEREAS, the Replat of Mincy Valley Homestead Acres depicts and describes a forty (40) foot wide strip of land for a road easement over and across a portion of the Arena Parcel of the Replat of Mincy Valley Homestead Acres, as per plat recorded in Slide Cabinet "H" at page 456, in the office of the Taney County Recorder of Deeds, legally described as follows: all of the West forty (40) feet, all of the South forty (40) feet, and all of the East forty (40) feet of said Arena Parcel ("Howe Park Road"); and

WHEREAS, the public has used and the County has expended public funds on Howe Park Road and the County Commission desires to formally accept, establish, and dedicate Howe Park Road as a county road for use by the public;

NOW, THEREFORE, the County Commission of Taney County, Missouri, orders, as follows:

 Incorporation. Each and every finding set forth in the whereas clauses set forth above are incorporated as the findings of the County Commission by reference.

2. Acceptance: Establishment: Dedication. The Taney County Commission hereby ratifies, accepts, and adopts the Arena Parcel and the Replat of Mincy Valley Homestead Acres, recorded in the office of the Taney County Recorder of Deeds, on August 18, 2005, in Plat Book/Slide H, Page 456-458 as it relates to Howe Park Road and accepts, establishes, and dedicates to the public Howe Park Road as a public road, legally described as a forty (40) foot wide strip of land for a road easement over and across a portion of the Arena Parcel of the Replat

AGREEMENT for

Bullet Proof Vests (15) THIS AGREEMENT dated the 18th day of ebruary 2020 is made between Taney County, Missouri, a political subdivision of the State of Missouri, (hereinafter "County") and Southern Uniform & Equipment of Carthage, Mo (-hereinafter "Contractor").

NOW, THEREFORE IN CONSIDERATION of the mutual considerations and obligations of the parties contained herein, the parties agree as follows:

1. Contract Documents. The contract documents to this Agreement for 15 Law Enforcement Vests ("Equipment") for the Taney County Sheriff's Department, through Greene County Missouri Contract #17-0885 / Greene County Bid #17-10601 shall include the quote dated January 28, 2020, Contractor response to RFP #17-10601, including all attached documents, the Agreement dated August 3, 2017, which are attached hereto and incorporated herein by reference as Exhibit A ("Contract Documents"). Contract documents, Product or Services data, specifications and literature submitted may be permanently maintained in the County Purchasing Office. In the event of a conflict between any of the foregoing Contract Documents, and this Agreement, the terms and conditions of this Agreement shall prevail and control.

2. Contract Price. The County agrees to purchase the Equipment from the Contractor and the Contractor agrees to sell to the County the Equipment described in this Agreement. The Purchase Price shall not exceed \$13,499.85. If certain unusual circumstances occur specific to Equipment availability, the County may consider all other options.

3. Contract Duration. This agreement shall commence on the date it is fully executed and terminate upon expiration of all applicable warranties. This agreement may only be extended by the order of the county subject to the pricing, and delivery clauses as agreed to, and offered by the contractor's bid response.

4. Billing and Payment. All billing shall be invoiced with specific department information and include bid reference Green County, Mo Contract #17-0885 for tracking. Billings and invoices may only include the prices provided for in this Agreement. No additional fees or extra services not included, or taxes, shall be included as additional charges in excess of the charges in this Agreement or the Contract Documents. The County agrees to pay all correct statements within thirty days of receipt; Contractor agrees to honor any cash or prompt payment discounts, if any are available, when County makes payment as provided therein. In the event of a billing dispute, the County reserves the right to withhold payment on the disputed amount.

5. Binding Effect. This Agreement shall be binding upon the parties hereto and their successors and assigns for so long as this Agreement remains in full force and effect.

6. Entire Agreement. This Agreement constitutes the entire Agreement between the parties and supersedes any prior negotiations, written or verbal, and any other bid or bid specification or contractual Agreement. This Agreement may only be amended by a signed writing executed with the same formality as this Agreement.
