<p>Shall the Board of Education of the Kirbyville R-VI School District of Taney County, Missouri, with no estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Eight Hundred Thousand Dollars (\$1,800,000) for the purpose of providing funds to construct secure entrances at both the Elementary and Middle Schools; to update, improve and expand existing school security and infrastructure; and to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.3500 per one hundred dollars of assessed valuation of real and personal property.</p>
