INTERGOVERNMENTAL AGREEMENT FOR MUTUAL AID AND CONSTRUCTION SERVICES

THIS INTERGOVERNMENTAL AGREEMENT is made on this _____ day of October, 2023 ("Effective Date") by and between Central Taney County Fire Protection District ("Central Taney FPD") and Taney County, Missouri ("County"). Such entities will be referred to herein as "Parties," collectively, and "Party" individually.

WHEREAS, Central Taney FPD wishes to construct a helipad at its headquarters, Station 5, in Kissee Mills, Missouri (the "Project").

WHEREAS, County desires to assist with construction of the Project.

WHEREAS, Section 70.220, RSMo., authorizes political subdivisions to contract and cooperate with one other for the planning, development, construction, acquisition, or operation of any public improvement or facility.

WHEREAS, Central Taney FPD and County desire to enter into a cooperative agreement for the purpose of allocating responsibilities with respect to constructing the Project.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the parties agree as follows:

1. <u>Purpose.</u> The purpose of this Agreement shall be for the construction of the Project.

2. <u>County's Construction Responsibilities.</u> County shall construct a helipad at Station 5, located at 21070 Highway 160, Kissee Mills, MO 65680. The helipad shall be constructed in accordance with Central Taney FPD's design and plans in a good and workmanlike manner. The County shall supply all labor and equipment for the Project.

3. Central Taney FPD's Responsibilities.

a. Central Taney FPD shall have or acquire all necessary property rights in order for the Project to be performed. Central Taney FPD shall supply all materials and supplies necessary for site preparation and for the Project. Central Taney FPD shall be responsible to obtain all necessary approvals and permits necessary to perform the Project.

b. Central Taney FPD shall reasonably cooperate with County to provide debris removal due to storm damage on an as-needed basis. This section shall not be construed to require any Central Taney FPD employee to provide any service that interferes with such employee's emergency response duties or training schedule.

4. <u>Term; Termination.</u> The term of this Agreement shall begin on the Effective Date set forth above and shall continue until completion of the Project. This Agreement may be terminated at any time, by either party, by providing thirty (30) days advance written notice to the other party.
