RE: Review of 2024 Septic Tank Pump Out Program Bids

Commissioners,

I have reviewed the bids received which were opened on December 13, 2023. In determining the lowest and best bid for the County, I look at the following:

- Based on the current 2023 numbers, the zip code areas of Branson, Forsyth, Hollister, Kirbyville, Ridgedale and Walnut Shade represent 76% of all pump outs approved. These areas are what I refer to as the core areas where the majority of pump out request are received. For these areas, Boerman Septic Services proposed cost is \$180 / location with S&S Pumping's proposed cost being \$150 / location.
- 2. The zip code areas of Bradleyville, Cedar Creek, Kissee Mills, Powersite, Protem Taneyville, Merriam Woods and Rockaway Beach represent 24% of all pump outs approved in 2023. Boerman Septic Services proposed cost for these areas range from \$180 to \$225 depending on location and driving distance with S&S Pumping's proposed cost ranging between \$150 to \$175 again, depending on location and driving distance.
- 3. Response Time Boerman Septic Services has stated "Immediate" as a response time after receipt of order. S&S Pumping has stated 24 to 72 hours. This program is designed to encourage and assist property owners in maintaining their septic tanks and systems. This program is not intended to provide immediate assistance to address emergencies. With that, I do not feel that a response time of 24 to 72 hours is unreasonable. In working with S&S Pumping these last two years this has never been a problem.

Recommendation:

Each year the goal is to pump out 500 septic tanks through the program. In looking at the cost numbers submitted, and using \$30 as a minimum savings per location based on the bid presented by \$&\$ Pumping, the County could realize a savings of approximately \$15,000 for the 2024 program year. With that, and barring any unforeseen issues, I would recommend that \$&\$ Pumping be awarded the 2024 program year contract.
