**Wednesday, October 9, 2024:** After opening responses received, initial details were noted by Road & Bridge Staff, in the absence of Devin Huff, Road & Bridge Administrator. All responses will be thoroughly reviewed.

**Thursday, October 10, 2024:** An agenda request has been made, and approved, to deliver a formal recommendation for award to the Taney County Commission on Tuesday, October 15, 2024.

**Tuesday, October 15, 2024:** After a thorough review of the responses received, let it be noted that only 3 out of 9 were compliant. The remaining 6 were either disqualified for Section 1 or did not comply with specifications requested. We recommend the Commission award Kraftsman International, Inc., Albemarle, North Carolina, as the best option for Taney County, and ask the Commission for a motion vote as such.

The Taney County Commission made a motion to award Kraftsman International, Inc., Albemarle, North Carolina, as Primary Supplier, and Westgate Trailers, Mountain Grove, Missouri as Secondary Supplier, and it passed by vote.
