### COOPERATIVE AGREEMENT

This Cooperative Agreement ("Agreement"), made and entered into this *U* day of 2024 ("Effective Date"), by and between Taney County, Missouri ("Taney County") and Mark Twain School District R-VIII ("District").

WHEREAS, section 70.220, RSMo. permits political subdivisions to contract and cooperate with other political subdivisions, private persons, firms, associations, or corporations for a common service;

WHEREAS, Taney County requires an area to stockpile roadway materials ("Materials");

WHEREAS, District has a location suitable for stockpiling the Materials and is willing to allow Taney County to stockpile the Materials in exchange for performing repairs to District's parking lot; and

WHREAS, Taney County agrees to make such repairs to District's parking lot in exchange for the right to stockpile the Materials.

4. <u>Liability.</u> District agrees that it shall be responsible for any and all claims, losses, and liabilities, of any nature whatsoever, to persons or property arising from the negligent or wrongful acts or omissions of School, its employees, agents, and representatives, without waiving its sovereign, governmental, or official immunities. Taney County agrees that it shall be responsible for any and all claims, losses, and liabilities, of any nature whatsoever, to persons or property arising from the negligent or wrongful acts or omissions of Taney County, its employees, agents, and representatives, without waiving its sovereign, governmental, or official immunities. Furthermore, Taney County shall be responsible for injury or death to individuals and for damage to real and personal property or materials arising directly from the repair work to the parking lot.

5. <u>Modification; Amendment.</u> This Agreement may be modified or amended by a writing, signed, dated and approved by the parties.

6. <u>Compliance with Laws.</u> The parties agree to comply with all local, state, and federal laws in performing the respective obligations under this Agreement.

This Agreement made and entered into this 10<sup>th</sup> day of <u>Jinne</u>, 202\_ ("Effective Date") by and between the County of Taney, Missouri ("County") and the City of Hollister, Missouri ("City").

WHEREAS, section 70.220, RSMo. permits political subdivisions to contract and cooperate with one another for the planning, development, construction, acquisition or operation of any public improvement or facility or common service; and

3. <u>Maintenance by County.</u> County agrees to maintain that portion of Historic Highway 165 located within City, as depicted in <u>Exhibit A</u>, which is incorporated herein by reference, as needed and using the same standard as other county roads.

## BUDGET STABILIZATION FUND GRANT APPLICANT PROJECT AGREEMENT

This Agreement ("Agreement") is entered into by and between the Missouri 911 Service Board ("Board" or "Recipient") and Stone County Emergency Services ("Applicant") under to the Agreement Between the Missouri 911 Service Board and the Missouri Department of Public Safety Fiscal Year 2024 ("MOU"), which MOU is attached and labeled Exhibit 1 hereto. This Project Agreement is effective only after it is fully executed, the Board has a copy(ies) of the written certification(s) of the governing body of each Applicant in the Application approving the Agreement, and the Board confirms in writing that the Lead Project Director, Project Directors and any other individuals deemed necessary by the Board have completed any training required by the Board and that all required match funds are available.

### WITNESSETH:

WHEREAS, the County is a political subdivision of the State of Missouri; and

WHEREAS, pursuant to the above stated authority the County may enter into agreements for the purpose of making improvements to sewer systems within Taney County through projects utilizing expenditures of Sewer Sales Tax Funds (hereinafter "Sewer Sales Tax"); and

WHEREAS, the County shall oversee sewer sales tax funds which may be made available for use in areas of Taney County to finance capital improvements to their wastewater infrastructure. It has been determined that the project (Village Wastewater System Improvements Project) is feasible and meets the criteria necessary under the Sewer Sales Tax Guidelines. This project will provide for the engineering design services necessary to develop plans and specifications specific to the rehabilitation of two lift stations, relocation of a collection system manhole out of an area prone to flooding during heavy rainfall events and the rehabilitation of a collection system manhole that has been damaged due to hydrogen sulfide gas. The purchase of one backup pump for the Main Lift Station is also planned for this project. The bidding phase portion of this project will be covered under this agreement.
