MEMORANDUM OF UNDERSTANDING
BETWEEN THE TANEY COUNTY, MISSOURI ("County"),
the TANEY COUNTY SHERIFF'S OFFICE ("TCSO"), and
the KIRBYVILLE R-VI SCHOOL DISTRICT ("District").

FOR EMERGENCY SITUATION ACCESS TO DISTRICT SECURITY CAMERAS
AND DOOR ACCESS READERS

WITNESSETH THAT:

WHEREAS, the provisions of Section 70.210 to 70.320, inclusive, RSMo., as amended, empower political subdivisions to contract and cooperate with any other political subdivision for a common service; and

WHEREAS, the District operates various school sites and has installed video surveillance cameras ("Security Cameras") and Door Access Readers ("Readers") to provide a safe educational environment for students and District employees; and

WHEREAS, TCSO is responsible for providing for the safety and welfare of Taney county residents, and District students and employees at District school sites through a prior MOU and amendments; and

WHEREAS, school districts and law enforcement share responsibility for school safety and work together with complementary policies and procedures to ensure a safe learning environment for students and staff members. As such, the District and the TCSO recognize the need for a shared understanding as to the use of Security Cameras and Door Access Readers at the schools in a way that enhances security and aids law enforcement while respecting the privacy expectations of members of the school community.

NOW, THEREFORE, the Parties agree as follows:

1. **Purpose.** The purpose of this MOU is to set forth guidelines for the District and TCSO as to the role and responsibilities of each in the use of Security Cameras and Door Access Readers in District schools.
2. **TCSO Access to Security Cameras and Door Access Readers: Emergency Situations.** In the event of an emergency situation which includes active shooter/s, bomb threats, or any other immediate threat to life, limb, or safety of building occupants ("Emergency Situations"), TCSO may access the Security Cameras' real-time footage and video recordings and any Door Access Reader. Emergency Situation Access shall extend to emergency situations that occur both during and after school hours. Emergency Situation Access shall also extend to after school hours when TCSO (1) is notified of an alarm sounding and/or suspect criminal activity on District property.

LEASE AGREEMENT

THIS AGREEMENT made and entered into this 7th day of October, 2024, by and between the Taney County Commission on behalf of **Taney County, Missouri**, (hereinafter referred to as "County" or "Lessor"), and Tail Wind Planes LLC, a Missouri limited liability company in good standing (hereinafter referred to as "Lessee").

WHEREAS, Taney County, Missouri is the owner of M. Graham Clark Field-Taney County Airport (hereinafter referred to as "Airport"), located in the County of Taney, State of Missouri; and

WHEREAS, County has space available for the operation of a flight school and said flight school would be a benefit to the community; and

WHEREAS, Lessee is desirous of securing and entering into an agreement (hereinafter referred to as "Agreement") to provide adequate facilities and services to meet the demands of the public, patrons, and other persons at the Airport for services including flight training of the type and character herein permitted by County; and

NOW THEREFORE, the parties hereto, for and in consideration of the covenants and agreements hereinafter contained to be kept and performed and the consideration to be paid to County by Lessee, do agree as follows:

LEASED PREMISES, TERM, RENTAL

That in consideration of the covenants and agreements herein contained on the part of the Lessee to be observed and performed, the Lessor does hereby lease and demise unto the Lessee and the Lessee does hereby take, lease and hire from the Lessor the premises which consists of certain space at the M. Graham Clark Field-Taney County Airport, located at Point Lookout, Taney County, Missouri, said premises more particularly described as follows:

(A) Terminal Building: Central Corner office and gift shop area.

To have and to hold unto the Lessee, its successors and assigns, for the term of one (1) year commencing the 1st day of November, and ending on the 31st day of October, 2025. At the expiration of the term of this Agreement, the agreement may be extended or a new agreement entered into after negotiation, upon the approval, in writing, of both parties.

Lessee shall pay rent to the Lessor in the amount of **FOUR HUNDRED DOLLARS AND ZERO CENTS (\$400.00)** per month. Said rent is due no later than the fifteenth (15th) day of each month. The rent shall be paid at the office of the Airport Manager at the Taney County Airport or at such place designated by said Airport Manager.

Dear Mr. Norcross:

On May 22, 2023, Taney County, Missouri entered into an Agreement for Tandem Dump Truck (1 or more) ("Agreement") with Tri-State Truck Center, Inc. for the purchase of one (1) or more tandem dump trucks based on a quote dated March 17, 2023 by virtue of Sourcewell Contract #060920-MAK.

Paragraph 7.b. provides that the Agreement may be terminated by the County upon thirty (30) days advance written notice if in the opinion of the Taney County Commission services or equipment are delayed or are not provided in conformity with specifications or variances authorized by the County. After seventeen months, Tri-State Truck Center, Inc. has not delivered and the County has not received the equipment specified by the Agreement. As a result, this letter shall constitute notice of termination thirty (30) days from today's date.

THIS AGREEMENT ("Agreement") dated the 7th day of October 2024, is made by and between Taney County, Missouri, a political subdivision of the State of Missouri, (hereinafter "County") and Hissong Kenworth Inc dba Kenworth of Canton, Canton, Ohio (hereinafter "Contractor").

NOW, THEREFORE IN CONSIDERATION of the mutual considerations and obligations of the parties contained herein, the parties agree as follows:

1. Contract Documents. The contract documents to this Agreement to purchase one (1) or more dump trucks ("Equipment") shall include two (2) Quotes, both of which are dated September 24, 2024 and the cooperative purchasing contract documents of Sourcewell Contract #032924-KTC, all of which are attached hereto and incorporated herein by reference as Exhibit A ("Contract Documents"). Contract Documents, Product or Services data, specifications and literature submitted may be permanently maintained in the County Purchasing Office. In the event of a conflict between any of the foregoing Contract Documents, and this Agreement, the terms and conditions of this Agreement shall prevail and control.

2. Contract Price. The County agrees to purchase the Equipment from the Contractor and the Contractor agrees to sell to the County the Equipment provided under this Agreement. The Purchase Price shall not exceed a total of \$5,136,188.00 for eleven (11) 15 ft. body style and seven (7) 13 ft. body style. If certain unusual circumstances occur specific to Equipment availability, the County may consider all other options.

3. Contract Duration. This agreement shall commence on the date it is fully executed and terminate upon expiration of all applicable warranties. This agreement may only be extended by the order of the County subject to the pricing, and delivery clauses as agreed to, and offered by the Contractor's bid response.

4. Billing and Payment. All billing must be invoiced with specific department information. Billings and invoices may only include the prices provided for via this Agreement. No additional fees or extra services not included, or taxes, shall be included as additional charges in excess of the charges in this Agreement or the Contract Documents. The County agrees to pay all correct statements within thirty days of receipt; Contractor agrees to honor any cash or prompt payment discounts, if any are available, when County makes payment as provided therein. In the event of a billing dispute, the County reserves the right to withhold payment on the disputed amount.

5. Binding Effect. This Agreement shall be binding upon the parties hereto and their successors and assigns for so long as this Agreement remains in full force and effect.

6. Entire Agreement. This Agreement constitutes the entire Agreement between the parties and supersedes any prior negotiations, written or verbal, and any other bid or bid specification or contractual Agreement. This Agreement may only be amended by a signed writing executed with the same formality as this Agreement.

Commissioner Williams moved to approve the Amended Order & Ordinance of the Taney County Commission Modifying a Property Tax Credit Pursuant to Senate Bill 190, Senate Bill 756, and 137.1050, RSMo. to provide Property Tax Relief on Senior Citizen's Primary Residence. Commissioner Wyatt seconded the motion. The motion passed by vote: Plummer (aye), Williams (aye), and Wyatt (aye).

**AMENDED ORDER & ORDINANCE
OF THE TANEY COUNTY COMMISSION**

***MODIFYING A PROPERTY TAX CREDIT PURSUANT TO SENATE BILL 190, SENATE
BILL 756 AND § 137.1050, RSMO. TO PROVIDE PROPERTY TAX RELIEF ON SENIOR
CITIZENS' PRIMARY RESIDENCE***

WHEREAS, in 2023, the Missouri legislature passed and the Governor signed Senate Bill 190 ("SB 190"), codified as Section 137.1050, RSMo; and

WHEREAS, SB 190 and Section 137.1050, RSMo., became effective on August 28, 2023; and

WHEREAS, under SB 190, certain eligible senior citizen taxpayers may receive a property tax credit; and

WHEREAS, a senior citizen taxpayer may qualify as an eligible taxpayer if the taxpayer is a Missouri resident; is eligible for Social Security retirement benefits; is an owner of record of a homestead or has legal or equitable interest in such property as evidenced by a written instrument; and is liable for the payment of real property taxes on such homestead;

WHEREAS, SB 190 and § 137.1050, RSMo. authorize a county to grant a property tax credit to eligible senior citizen taxpayers residing in such county if a county adopts an ordinance authorizing such credit; and

WHEREAS, on May 20, 2024, pursuant to SB 190 and Section 137.1050, RSMo. the County Commission of Taney County, Missouri established and created a tax credit for certain eligible senior citizen taxpayers within Taney County effective for tax year 2024 (the "Order"); and

WHEREAS, in 2024, the Missouri legislature passed and the Governor signed Senate Bill 756 ("SB 756"), which modified and clarifies certain provisions contained in § 137.1050 and which became effective on August 28, 2024; and

WHEREAS, as a result, the County Commission of Taney County, Missouri desires to amend the Order by rescinding and replacing the Order dated May 20, 2024, as follows:

NOW, THEREFORE, IT IS HEREBY ORDERED by the County Commission of Taney County, Missouri, as follows:

1. Amendment. The County Commission Order adopted on May 20, 2024, and the provisions set forth therein are hereby repealed and replaced in their entirety by this Amended Order and Ordinance.

2. Adoption and Enactment. The County Commission of Taney, Missouri hereby authorizes a real property tax credit to eligible taxpayers residing in Taney County, Missouri in an amount equal to the eligible taxpayer's eligible credit amount. No taxpayer shall be deemed

purposes of calculating the tax credit prior to the date of enactment of this Order and Ordinance shall be construed to authorize or require the any refunds of taxes already paid prior to the effective date.

Definitions. For purposes of this Order and Ordinance, and pursuant to the of SB 190 and § 137.1050, RSMo., the following words and phrases shall have the meanings:

- i. “Eligible Credit Amount”: the difference between an eligible taxpayer’s real property tax liability on such taxpayer’s homestead for a given tax year, minus the real property tax liability on such homestead in the eligible taxpayer’s initial credit year.
- ii. “Eligible Taxpayer”: A Missouri resident who:
 - i. Is sixty-two (62) years of age or older;
 - ii. Is an owner of record of a homestead or has a legal or equitable interest in such property as evidenced by a written instrument; and
 - iii. Is liable for the payment of real property taxes on such homestead in Taney County, Missouri.
- iii. “Homestead”: real property actually occupied by an eligible taxpayer as the primary residence. An eligible taxpayer shall not claim more than one primary residence.

Tax Credit; Statement of Tax Due. The eligible tax credit amount granted pursuant to this Order and Ordinance shall be calculated as follows:


- i. For taxpayers that meet the requirements for an Eligible Taxpayer prior to or in 2024, the difference between the eligible taxpayer’s real property tax liability on the homestead in the 2025 tax year (and each subsequent tax year) minus the real property tax liability on the taxpayer’s homestead for the 2024 tax year (the “Initial Credit Year”).
- ii. For all other taxpayers, any taxpayer that meets the requirements for an Eligible Taxpayer after 2024, the eligible tax credit amount shall be calculated as the difference between the eligible taxpayer’s real property tax liability in the given tax year, minus the real property tax liability on the homestead in the year in which the taxpayer meets the requirements of paragraph 3.b. (also referred to as the “Initial Credit Year”).

If in any tax year subsequent to the eligible taxpayer’s initial credit year the eligible taxpayer’s real property tax liability is lower than the liability in the initial credit year, such tax year shall be considered the eligible taxpayer’s initial credit year for all subsequent tax years. The amount of tax credit shall be noted on the statement of tax due sent to the eligible taxpayer by the Taney County Collector of Revenue.


No tax credit shall be granted pursuant to this Order and Ordinance to a taxpayer that owes delinquent taxes, interest, or penalties.

5. Tax Revenue Calculation. For the purposes of calculating property tax levies pursuant to § 137.073, RSMo., the total amount of credit authorized pursuant to this Order and Ordinance shall be considered tax revenue, as such term is defined in § 137.073, RSMo., actually received by the respective political subdivisions levying a real estate property tax in Taney County.
6. New Construction; Improvements. If an eligible taxpayer makes new construction and improvements to such eligible taxpayer's homestead, the real property tax liability for the taxpayer's initial credit year shall be increased to reflect the real property tax liability attributable to the new construction and improvements.
7. Annexation. If an eligible taxpayer's homestead is annexed into a taxing jurisdiction to which the eligible taxpayer did not owe real property tax in the eligible taxpayer's Initial Credit Year, then the real property tax liability for the taxpayer's Initial Credit Year shall be increased to reflect the real property tax liability owed to the annexing taxing jurisdiction.
8. Implementation. The County and each of its elected officials shall be authorized and empowered to adopt such rules and procedures as they deem necessary in order to carry out and implement the provisions of this Order and Ordinance and to develop and require such documents, applications and instruments as may be necessary or desirable to permit the application of the tax credits authorized herein, and to carry out, comply with and perform the requirements of the provisions set forth in this Order and Ordinance.
9. Exclusions. The tax authorized pursuant to Article III, Section 38(b) of the Missouri Constitution relating to the blind pension fund, any bonded indebtedness of a political subdivision located partially or wholly within Taney County and any other taxes levied against real property and protected or otherwise guaranteed pursuant to the Missouri Constitution shall be excluded from the calculation of the tax credit granted pursuant to this Order and Ordinance.
10. Date of Applications; Applicants. Beginning in 2025, applications for tax credits shall be received on or before June 30 of each year in order to be eligible for the tax credit in that calendar year. Applications received after June 30 shall apply for the following year. An Eligible Taxpayer seeking a property tax credit pursuant to this Order and Ordinance shall submit an application in writing on forms approved by the County containing the required information. Applications shall be presented to the County Commission for approval or denial, and any such approval or denial shall be set forth in a Commission Order.
11. Political Subdivisions; Notification. This Order and Ordinance shall apply to all political subdivisions located partially or wholly within Taney County, Missouri that levy and collect real estate property taxes. The County shall notify each political subdivision located within the county of the total credit amount applicable to such political subdivision by no later than November thirtieth of each year.
12. Closed Records. Except as otherwise provided in Chapter 610, RSMo., taxpayer information submitted in the application and supporting documents shall be a closed record; provided, however, any information set forth in any record that is otherwise a public record shall be subject to disclosure as provided by law.
13. Compliance. No person shall knowingly submit false or misleading information in support of an application under this ordinance. Any person convicted of violating this ordinance shall be punished as provided by law, including, but not limited to § 575.060, RSMo.
14. Severability. The provisions of this Order and Ordinance shall be severable. If any provision of this Order and Ordinance is found by a court of competent jurisdiction to be unconstitutional, invalid, or unenforceable, the remaining provisions shall be treated as being in full force and effect.
15. Passage and Approval. This Order and Ordinance shall be in full force and effect from and after the date of its passage and approval by the County Commission and shall be effective as of August 28, 2024, for tax year 2024 and each year thereafter.


