- 1. Clerks are unable to assist you in completing this form.
- 2. There are two ways to complete a petition.
 - a. You may print off the form and handwrite your information in the blanks.
 - i. If you choose this method <u>all information needs to be legible</u>.

 The Judgment is completed based upon the petition filed. If the petition is incorrect, the Judgment will be incorrect or denied.
 - b. You may type in the blanks or re-type the entire form.
- 3. Please double check that the petition includes the correct make, model, year, and VIN# and what valuable consideration the property was acquired.
- 4. The petition must be signed in front of a notary before filing.
- 5. Upon submitting the petition, the filing fee is \$48.50. Cash, check, or money order accepted. Credit cards are also accepted with a \$2 processing fee.

After submitting the petition, a copy will be sent to the Department of Revenue for review. The DOR will send answers to both the court and to you at the address listed on your petition.

If/When a Judgment is signed by the judge, a certified copy will be sent to you at the address provided on your petition. You may then take the certified copy of your Judgment to the license bureau to obtain a new title.

If a hearing is scheduled, you will be notified in writing to the address provided.
