**AMENDMENT TO INTER-GOVERNMENTAL FUNDING AGREEMENT

**VILLAGE WASTEWATER SYSTEM IMPROVEMENTS PROJECT
(ENGINEERING DESIGN & BIDDING PHASE)**

THIS AGREEMENT is made and entered into between Taney County, Missouri (hereinafter referred to as “County”) and the Village of Bull Creek (hereinafter referred to as “Village”).

- 1. The County and Village entered into an Inter-Governmental Funding Agreement on June 10, 2024, a copy of which is attached hereto as Exhibit “A” and incorporated herein by reference, for the purpose of completing the items as outlined in the above referenced funding agreement by April 1, 2025.
- 2. The project has suffered delays due to the ability to gain adequate access to the existing sewer line along Bull Creek due to new home construction and subdivision development that has occurred over the last several years. With that, the Village is requesting a new funding agreement termination date of October 1, 2025 to allow additional time for this phase of the project to be completed and reimbursement process requirements to be met.
- 3. The County agrees to extend the funding agreement termination date to October 1, 2025.
- 4. All other aspects of the agreement(s) for this project remain in effect.
