ROAD VACATE(S)

VACATION OF PLATTED PUBLIC STREETS – ROYCE ST., RAMONA ST. & RUBY ST. FILE NO. 25-073RB

Timothy Schwartz, Trustee, and William McCullah, Attorney, were present.

Commissioner Williams read the Petition for Vacation of Platted Public Streets into the record:

"Comes now Timothy James Schwartz, Trustee of the Revocable Living Trust of Timothy James Schwartz under instrument dated September 7, 2022, by and through William McCullah, his attorney, and pursuant to the provisions of 71.270 RSMo, state as follows:

Streets to be vacated ("the Streets"): Royce Street, Ramona Street, and Ruby Street lying north
of Barton Road (formerly known as Horse Shoe Drive) in Massey's Second Addition to Bull
Shoals Lake, a subdivision in and to Taney County, Missouri recorded at Book 5, Page 85,
Recorder's Office of Taney County, Missouri.

2. Ownership of lands adjoining the streets to be vacated:

- a. Petitioner is the owner of all lots touching the described roads.
- b. The Southern terminus of the described roads in the northern right-of-way boundary of Barton Road (formerly known as Horse Shoe Drive).
- c. The Northern terminus of the described roads is at the Corps of Engineers fee take line.
- d. The roads end at the Corps of Engineers fee take line.
- 3. The Streets have never been opened or used, are of no public benefit, and have never been of any public benefit.
- 4. No utility services are located on or alongside the roads. However, notice has been sent to White River Electric Cooperative and Taney County Regional Sewer District.
- 5. No person or entity will be disadvantaged if the petition is granted.

- 6. Notice will be published in the Branson Tri-Lakes News, a legal newspaper of general circulation published in the County, giving at least fifteen days' notice that this Petition will be presented to the Commission.
- 7. The opening day of the July 2025 term of the Commission is July 7 2025. Notice will be given that the Petition will be presented to the Commission on that date.

Wherefore, Petitioner prays that the County Commission order that the described streets that were platted and dedicated to the public, be vacated pursuant to the provisions of 71.270 RSMo."

WHEREAS, the Petitioner owns the ground lying on both sides or fronting the portion of the Roads proposed to be vacated.

WHEREAS, the Roads proposed to be vacated are outside the limits of any incorporated town, village, or city.

WHEREAS, notice as required pursuant to law has been given at least fifteen (15) days before the first day of the current term of the County Commission to which this Order is being considered, which notice shall apply to and be binding upon all persons and corporations whatsoever having any interest in or title to the lands, or any part thereof, over which said portion of the Road may run.

VACATION OF A PORTION OF SYCAMORE CHURCH ROAD FILE NO. 25-071RB Carl Bonnell, Deputy Regional Director, Ozark Region, Missouri Department of Natural Resources, was present.

Commissioner Williams read the Petition for Vacation of a Public Road into the record.

"To the Honorable Commission of Taney County, Missouri:

We, the undersigned citizen of Taney County, at least twelve duly qualified and competent adult petitioners, residents and registered voters in Branson Township, respectfully represent and aver that the following described portion of Sycamore Church Road (spur), Route No. 248-20I, is of no public utility and that continued maintenance of said road is an unreasonable burden up Taney County. We, therefore, request a vacation of the following described portion of road pursuant to section 227.110 RSMo:

A part of Sycamore Church Road, Route No. 248-20I, located in Branson Civil Township in Taney County, Missouri, and lying in part of the Southeast quarter of Section 15, Township 23 North, Range 22 West of the Fifth Principal Meridian, more particularly described as commencing at 5/8 inch Rebar, described in Missouri State Land Survey Document #600-775000, set to mark the quarter section corner between Sections 15 and 22 in said township; thence South 88 degrees 48 Minutes East, a distance of 1312.25 feet to the Southeast corner of the Southwest quarter of the Southeast quarter of said section 15; thence along the East line of said quarter-quarter section, North 01 degree 37 minutes 10 seconds East, a distance of 343.13 feet to a point on the centerline of Sycamore Church Road, Route No. 248-20; thence along said centerline, North 68 degrees 40 minutes West, a distance of 22.6 feet to an angle point; thence North 67 degrees 41 minutes West, a distance of 91.0 feet to a point of curvature; thence along the arc of a curve to the left, having a radius of 1950.0 feet, through a central angle of 03 degrees 40 minutes, an arc distance of 124-79 feet to a point of tangency; thence North 71 degrees 21 minutes West, a distance of 41.37 feet to a point of curvature; thence along the arc of a curve to the right, having a radius of 173.5 feet, through a central angle of 30 degrees 44 minutes, an arc distance of 93.07 feet to a point of tangency; thence North 40 degrees 37 minutes West, a distance of 10.75 feet to the end of Sycamore Church Road, Route No. 248-20 and the beginning of Noland Road, Route No. 248.20H and Sycamore Church Road(spur), Route 248-20I; thence along the centerline of said Sycamore Church Road (spur), Route No. 248-20I, North 49 degrees 45 minutes East, a distance of 20.0 feet to the TRUE POINT OF BEGINNING of the herein described centerline of Sycamore Church Road (spur), Route No. 248-20I, petitioned to be vacated; thence North 49 degrees 45 minutes East, distance of 232.9 feet to a point of curvature; thence along the arc of a curve to the left, having a radius of 80.0 feet, through a central angle of 106 degrees 05 minutes 30 seconds, and arc distance of 148.13 feet to a point of tangency; thence North 56 degrees 20 minutes 30 seconds West, a distance of 203.5 feet to a point of curvature; thence along the same arc of a curve to the right, having a radius of 58.0 feet, through a central angle of 89 degrees 50 minutes 30 seconds, an arc distance of 90.95 feet to a point of tangency; thence North 33 degrees 30 minutes East, a distance of 44.4 feet to a point of curvature; thence along the arc of a curve to the left, having a radius of 37.5 feet, through a central angle of 92 degrees 34 minutes, an arc distance of 60.58 feet to a point of tangency; thence North 59 degrees 04 minutes West, a distance of 145.3 feet and continuing as far as Taney County claims jurisdiction.

A brief depiction of the road location is incorporated herein, and attached as Exhibit A. A more detailed drawing will accompany this petition.

The petitioners state the following facts to support of the petition for vacation:

- 1. The above described portion of road lies entirely within property owned by the Missouri Department of Natural Resources.
- 2. No other landowners are served by the portion of road.
- 3. This portion of road terminates without providing a connection to any other public road.
- 4. Public access to this portion of road has been blocked by a locked gate since Missouri Department of Natural Resources acquired the surrounding property in 2016.

5. Since 2016, Taney County has deferred expending public money to maintain the road and a low water crossing."

Commissioner Williams moved to bind over and set the petition to vacate a portion of Sycamore Church Road for the next Term starting in October. Commissioner Keys seconded the motion. The motion passed by vote: Plummer (aye), Williams (aye), and Keys (aye).
