ROAD VACATION OF A PORTION OF WALNUT DRIVE FILE NO. 25-099RB

Commissioner Williams read into the record the “Petition to vacate a portion of Walnut Drive.”

PETITION

1. Comes now Petitioners Jonathan Schwinger and Rebecca Larussa, husband and wife, and state to the Commission that they are the owners of all properties which touch that portion of Walnut Drive which said Petitioners are requesting be vacated.
2. That said portion of Walnut Drive requested to be vacated is not being used by the general public and is unimproved;
3. That the portion of the road sought be vacated is shown on the attached plat marked Exhibit A and incorporated herein by reference.
4. The area sought to be vacated is not located in any municipality.
5. Your Petitioners further state to the Commission that it would be to the best interests of the public that the portion of Walnut Drive described in the caption of this petition to be vacated.

ROAD VACATION OF A PORTION OF SYCAMORE CHURCH ROAD FILE NO. 25-071 RB

Carl Bonnell, applicant, appeared in front of the commission.

Commissioner Williams read into the record the Petition for Vacation of a Public Road.

Petition to vacate public land location parcel 7-5.0-15-000-000-016.000 Township 23 North Section 15, Range 22 W. Taney County Commission has duly considered the petition for the Southern Department of Resources the Division of State Park hereafter DSP along with twelve duly qualified and competent adult petitioners, who are registered voter to vacate that portion of Sycamore Road pursuant to section 228.110, RSMo. described as follows:

A part of Sycamore Church Road, Route No. 248-20I, located in Branson Civil Township in Taney County, Missouri, and lying in part of the Southeast quarter Of Section 15, Township 23 North, Range 22 West of the Fifth Principal Meridan, more particularly described as commencing at a 5/8 inch Rebar, described in Missouri State Land Survey Document #600-77500, set to mark the quarter section corner between Sections 15 and 22 in said township; thence South 88 degrees 48 minutes East, a distance of 1312.25 feet to the Southeast corner of the Southwest quarter of the Southeast quarter of said Section 15; thence

A map showing road location is incorporated herein and attached in Exhibit A and affidavit attached as Exhibit B. Immortalizing the public notice of this application having been given in accordance to Section 228.110 RSMo. The County Commission finds notice to be satisfactory to duly attained jurisdiction of the subject matter and of all parties herein and find the facts justify vacation of the portion of the public roads identified.

Wherefore the commission determines the portion of Sycamore Church Road described is hereafter will be vacated and no longer the property to Taney County and direct petitioner to cause order to be recorded in the land records for Taney County. So ordered.

NOW ON THIS DATE, being a regular day of the October term of the County Commission of Taney County, Missouri, comes the Petitioners and present to the Commission the Petition praying for that portion of Sycamore Church Road, located in Taney County, Missouri, and finds as follows:

The Commission having read said Petition and having conducted a hearing on the Petition on October 6, 2025, and heard the evidence adduced in support thereof, does find as follows:

1. The Petition was submitted pursuant to § 228.110, RSMo. and was signed by at least twelve residents of the township through which the subject road runs, and was publicly read on the first day of the July term, and the matter continued without further proceedings until the next term.
2. Notice of the filing of the Petition and of the road sought to be vacated was posted in not less than three public places in such township at least twenty days before the first day of the October term of the County Commission.
3. A copy of the notice of the filing of the Petition was personally served on all the persons residing in the district whose lands are crossed or touched by the road proposed to be vacated in the same manner as other notices are required to be served by law.
4. The Petition was again publicly read on the first day of the October term of the County Commission.
5. No remonstrances were made in writing, signed by at least twelve residents of the township.
6. The Petition meets all requirements of § 228.110, RSMo. and the portion of the subject road sought to be vacated is useless and the repairing of the same an unreasonable burden upon the district.

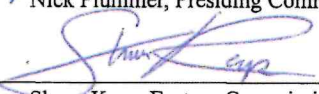

AGREEMENT

This Agreement (“**Agreement**”) is entered into by and between Scott Starrett (“**Consultant**”) and Taney County, Missouri (“**County**”), on the date first written below.

WHEREAS, Consultant was previously employed with County in an Administrator role;
and

WHEREAS, Consultant’s employment with the County ended effective February 7, 2025;
and

WHEREAS, County desires Consultant to provide consulting services from time to time on an as-needed basis for the purpose of completing any of Consultant’s open projects specifically relating to Planning & Zoning, including Environmental Services.

NOW, THEREFORE, and in consideration of the mutual covenants and agreements contained herein, the parties hereto agree as follows:

1. **Term.** The term of the Agreement shall be from September 2, 2025, until the completion of the Project, as defined below (the “**Term**”), subject to termination prior to expiration of the Agreement pursuant to Section 4 herein.

2. **Duties of Consultant.** During the term of this Agreement, Consultant agrees to render consulting services to County on an as-needed basis and in the sole discretion and in matters as requested by County relating to any projects Consultant was actively working on as of his final day of employment with County and which remain open or incomplete (the “**Project**”).

3. **Consulting Fees.**

a. As compensation for services rendered by Consultant to County pursuant to this Agreement, County shall pay Consultant at the base consulting fee rate of Twenty-Seven Dollars and Fifty Cents (\$27.50) per hour. Consultant will report consultation hours worked bi-weekly to County, in writing. Payment shall be made by the following bi-weekly period in which consulting services occur, provided accurate and approved billable time records are received by County.

b. Consultant shall also receive from County with respect to each consulting service or project performed under the Agreement reimbursement for out-of-pocket expenses provided that any such out-of-pocket expenses, including any mileage, are approved in advance by County. County shall reimburse any such approved expenses at the same time as the compensation for consulting services are paid, provided that Consultant’s invoices or documentation sets forth detailed information about the expenses for which reimbursement is sought. County may advance amounts from time to time to Consultant as determined by County in its sole discretion.

THIS AGREEMENT dated the 6th day of October 2025 is made between Taney County, Missouri, a political subdivision of the State of Missouri ("County") and Limb Buster LLC, of Smithton, Missouri ("Contractor").

IN CONSIDERATION of the parties performance of the respective obligations contained herein, the parties agree as follows:

1. Contract Documents. The contract documents to this Agreement for the purchase of three (3) arm saw attachments ("Equipment") shall include the Contractor's bid response to County's Request For Bid #202508-586 and any applicable addenda. All such documents shall constitute the "Contract Documents", which are attached hereto as Exhibit A and incorporated herein by reference. Service or product data, specifications and literature submitted with bid response may be permanently maintained in the County Purchasing Office bid file for this bid if not attached. In the event of a conflict between any of the foregoing Contract Documents, and this Agreement, the terms and conditions of this Agreement shall prevail and control.

2. Contract Price. The County agrees to purchase from the Contractor and the Contractor agrees to sell the Equipment to the County pursuant to the Contract Documents for the total contract price of \$45,216.00. If certain unusual circumstances occur specific to Vehicle availability, the County may consider all other options.

3. Contract Duration. This Agreement shall commence on the date it is fully executed and terminate upon expiration of all applicable warranties, subject to the provisions for termination specified below. This Agreement may only be extended by the order of the County subject to the pricing and delivery clauses agreed to and offered by the Contractor's bid response.

4. Billing and Payment. All billing shall be invoiced with specific department information for tracking. Billings and invoices may only include the prices provided for in this Agreement. No additional fees or extra services not included, or taxes, shall be included as additional charges in excess of the charges in this Agreement or the Contract Documents. The County agrees to pay all correct statements within thirty days of receipt; Contractor agrees to honor any cash or prompt payment discounts, if any are available, when County makes payment as provided therein. In the event of a billing dispute, the County reserves the right to withhold payment on the disputed amount.

5. Binding Effect. - This agreement shall be binding upon the parties hereto and their successors and assigns for so long as this agreement remains in full force and effect.

6. Entire Agreement. This Agreement constitutes the entire agreement between the parties and supersedes any prior negotiations, written or verbal, and any other bid or bid specification or contractual agreement. This Agreement may only be amended by a signed writing executed with the same formality as this Agreement.
