David Clark, County Auditor, presented the 2026 Taney County Budget to the Commission for approval.

Commissioner Williams moved to approve the 2026 Taney County Budget as presented. Commissioner Keys seconded the motion. The motion passed by vote: Plummer (aye), Williams, (aye), and Keys (aye).

**COUNTY OF TANEY, MISSOURI  
2026 BUDGET MESSAGE**

It is my pleasure to present to you the 2026 Budget for Taney County, Missouri. It was prepared on an actual cash-based balance and with estimated revenues based upon actual revenues and expenditures from previous years as well as other relevant information. The 2026 Proposed Budget has been revised following budget discussions and a public hearing. During budget discussions, the Taney County Commission agreed to keep the COLA at the proposed amount of 3.0 percent.

The 2026 Taney County Budget starts the new fiscal year with a beginning balance of \$72,099,051. The overall outlook of projected revenues is \$69,967,660. The appropriated expenditures are \$92,932,725. The projected ending balance is \$49,133,986. Included in the appropriated expenditures are emergency funds and contingency funds which are used for unforeseen expenditures.

The General County Revenue (GCR) Fund showed a healthy reserve at the end of the calendar year 2025 of \$28,837,926. For the 2026 Budget, the anticipated revenues are \$24,158,251, and the anticipated expenditures are \$24,727,018. Included in these expenditures are the Emergency Funds of \$775,000, Contingency Funds of \$500,000, and Capital Improvement Funds of \$500,000. It also includes a County Airport Capital Improvement of \$185,000. The estimated 2026 ending balance for GCR is \$28,269,159.

The Taney County Road and Bridge has two separate Funds. These funds include the Road and Bridge CART Fund and the Road and Bridge Trust Fund. These Funds show a combined reserve at the end of the calendar year 2025 of \$13,955,690. The total 2026 budgeted revenues are \$16,377,800 and the total expenditures are \$20,480,684. Some of these expenditures include the Capital Improvement of \$2,000,000 and the Contingency of \$1,500,000. The projected 2026 ending balance for these funds is \$9,852,806.

The Law Enforcement Fund has a reserve of \$3,808,459. The anticipated revenues are \$9,562,227 and the anticipated expenditures are \$12,997,404. Included in these expenditures is the maintenance of the Judicial Building, and expenses of the Sheriff, Correction, Prosecutor, and Juvenile Departments.

The Taney County Sewer Fund ended the calendar year 2025 with a balance of \$18,832,059. The budgeted revenues are \$12,800,000 and the budgeted expenditures are \$23,605,561. A great majority of these expenditures are going to major sewer development projects. Included in these expenditures are the Contingency of \$1,000,000 and Environmental Services of \$113,830. The Sewer Funds estimated ending balance for 2026 is \$8,026,498.

I am privileged to be the Taney County Auditor and serve the people of Taney County. With the grateful help of the Elected Officials, Department Heads, and Staff, I present for your review and finalization the 2026 Taney County Budget.

NOW ON THIS DATE, the County Commission of Taney County, Missouri, takes up and considers the vacation of Oak Street, Elm Street, Alva Street, County Road and Cecil Street (collectively "Roads"), and finds as follows:

WHEREAS, the Petitioner has requested by Petition to the County Commission to vacate the Roads, as described in Exhibit A, which is attached hereto and incorporated herein by reference, pursuant to Section 71.270, RSMo. describing the street, avenue, road, alley, public easement, public square or common or part of thereof to be vacated.

WHEREAS, the Petitioner owns the ground lying on both sides or fronting the portion of the Road proposed to be vacated.

WHEREAS, the portion of the Road proposed to be vacated is outside the limits of any incorporated town, village, or city and the street, avenue, road, alley, public easement, public square or common was marked on the recorded plat of said subdivision;

WHEREAS, notice as required pursuant to law has been given at least fifteen (15) days prior to the term of the County Commission at which such Petition was presented, that application would be made at that term of the Commission for the vacation of the Road, which notice shall apply to and be binding upon all persons and corporations whatsoever having any interest in or title to the lands, or any part thereof, over which said portion of the Road may run.

WHEREAS, the utility providers which provide service in the area of the Road sought to be vacated have been notified of the Petition.

WHEREAS, no person interested in such subdivision appeared and showed cause to the County Commission as to why the vacation of the Road should not be made and the Commission hereby makes this Order for the vacation as requested in the Petition.


NOW, THEREFORE, the Taney County Commission orders as follows:


1. Incorporation. Each and every finding set forth in the whereas clauses set forth above are incorporated as the findings of the County Commission by reference.
